



THE DAY WEDDING GIVEAWAY TERMS AND CONDITIONS:

- This Giveaway, and prize draw is organised and promoted by Venu Nouveau (PTY) Ltd. (Registration Number 2018 / 585968 / 07)
- The wedding giveaway is open to all members of the public, who are over the age of 18.
- The winners should be engaged by the time of the announcement.
- No prizes may or shall be awarded to any person who is a director, member, partner, or all-inclusive supplier of Venu Nouveau or to the supplier of any goods or services in respect of the competition, nor any person otherwise associated with the prize draw (each a "Promoter") and/or any family member of a Promoter of the persons are eligible to enter the giveaway.
- By entering the giveaway, you are deemed to have read and accepted these terms and conditions. All entry instructions form part of these terms and conditions.
- Each participant who submits an entry into the giveaway also gives permission for Venu Nouveau to share their email address with each sponsor of the prize draw for the sole purpose of direct marketing, in the form of emails, social media or newsletters and will not be disclosed to any other entity or person without the prior consent of the participant. Any personal data submitted by a participant will be used solely as aforementioned and in accordance with current South African data protection legislation and the poppy act.
